1. Context: ERP implementation in Vietnam²

The Project on 'Support for REDD+ readiness preparation in Vietnam - Phase 2 (FCPF-2) was granted US\$ 5 million by the Forest Carbon Partnership Facility (FCPF) through the World Bank (WB) to continue REDD+ readiness preparation activities in six provinces in the North Central Coast (NCC) region, namely Thanh Hoa, Nghe An, Ha Tinh, Quang Binh, Quang Tri and Thua Thien-Hue from November 2016 to December 2020. The Management Board for Forestry Projects (MBFP) under the Ministry of Agriculture and Rural Development (MARD) is the Project Owner.

During the three years of implementation, the FCPF-2 Project implemented many legal^3 and

technical support activities to help Vietnam to get REDD+ ready. Some remarkable results include the support to the Government of Vietnam to develop the Emission Reductions Program Document (ER-PD) which was accepted by the Carbon Fund; capacity building on REDD+ readiness especially in the NCC region to be ready for the ER Program (ERP) implementation; and REDD+ readiness preparation in terms of capacity building, communication, Monitoring-Reporting-Verification (MRV), safeguards, improved legal frameworks; and completion of safeguards reports, including: Environmental and Social Management Framework (ESMF), Resettlement Policy Framework (RPF), Process Framework (PF), Ethnic Minority Planning Framework (EMPF) and Gender Action Plan (GAP).

Vietnam thereby shall mobilize resources to implement the ER-P to reduce about 26 million tons of CO₂ and receive payments for the results verified in a transparent manner. The World Bank commits to buy 10.3 million tons of CO₂, equivalent to about 51.5 million USD of payment. With an adaptive collaborative management approach (ACMA), the ERP will be able to address the drivers of deforestation and forest degradation, many of which are beyond forestry, in cooperation with different stakeholders in order to improve the effectiveness and efficiency of forest management and protection while providing the communities with various types of carbon and non-carbon benefits. Policies and measures include enhancement and implementation of the policy framework related to land use and land use planning, field interventions and deforestation to include livelihoods activities. At the moment, the FCPF-2 is supporting VNFOREST and MARD in negotiating commercial terms of the Emission Reductions Payment Agreement (ERPA).

For now, MARD is still waiting for an approval from the Prime Minister to negotiate the ERPA.

2. Context: the FCPF Capacity Building sub-project and the targeted communes

Hoa Binh Cooperative has benefited from a capacity building sub-grant under the FCPF Capacity Building Program through the project *"Capacity Building for the Ethnic Communities to be Ready to Actively Participate in REDD+ as an Independent Stakeholder through Their Legal Entities"*. This was up-scaled and focused on 4 communes of Cat Van, Thanh Lam, Hoa Quy and Xuan Quy in Nhu Xuan district, Thanh Hoa Province (within the ERP area of Vietnam). The sub-project was implemented from 31 May 2017 to 31 August 2019 with a budget of US\$78,320.36. Some achievements were:

2,011 members of 159 Self-Governing Groups⁴ (traditional group of households in nature, SGGs) benefited from a series of capacity building activities⁵. Their leaders were also trained as community trainers which they call 'FPIC Teams';

Vo Nhai district, Thai Nguyen Province: 119 SSGs with 2,038 members from 6 cooperatives (Hoa Binh, 45 SGGs and Thong Nhat, 15 SGGs both in Binh Long commune; Phuong Giao, 13 SGGs in Phuong Giao commune; Ba Nhat, 10 SGGs in Phu Thuong commune; Trang Xa, 16 SGGs in Trang Xa Commune; and Dan Tien, 20 SGGs in Dan Tien commune.

- Two (2) cooperatives: Rung Xanh in Hoa Quy commune and Quyet Thang in Xuan Quy commune were organized with 22 SGGs comprising 723 households;
- The above SGGs signed a 7-year forest protection contract with the district government to protect 1,050 ha of natural protection forest and received payment for 2019; and
- An alliance of 4 cooperatives (Nhu Xuan Alliance of Community Forest Owner Cooperatives or NACFO) in Nhu Xuan district, Thanh Hoa was established.

The Bu Mun forest (see map below) has around 2,900 ha of natural protection and production forest. Of which, the forest use rights over 633.5 ha within Cat Van commune were allocated⁶ to members of Thanh Son Lam Cooperative (10 SGGs with 236 households) ; and 1,231.55 ha within Thanh Lam commune to members of Thanh Trung Cooperative (8 SGGs with 247 households). The remaining forest area of around 1,050 ha which are not allocated to any forest owners as defined by the law and under the temporary management of the Commune People's Committee is covered by a 7 year (from 2019 to 2025) forest protection contract signed between the local government and members of Rung Xanh (15 SGGs with 460 households) and Quyet Thang (7 SGGs with 263 households) co-operatives in Hoa Quy and Xuan Quy communes, respectively.


This proposal requests a cost extension to the sub-project to continue supporting the 40 SSGs in the same four communes by improving the capacity of the NACFO and its members, including the key female and male leaders of the cooperatives and heads of SGGs/community forest owners and forest protection contractors to be ready to participate in ERP implementation as a stakeholder. Under the previous capacity building sub-grant, the NACFO developed the initial ideas for the proposal "Community based initiative to reduce the emission by increasing the forest Carbon stock" applying the model "Inter-community – landscape base – customary laws forest protection"⁷ but it

The cards are issued and managed by the director of each co-operative; 2) Each co-operative ensures that its members do not destroy the forest of other cooperatives; 3) The cooperatives support each other when forest is destroyed by outside loggers or burnt; 4) A community forest protection convention which includes a number of articles containing customary laws and state laws for example: Article 9: Prohibited acts in forestry activities; Article 22: Forest withdrawal; Article 73: General rights of forest owners; Article 74: General obligations of forest owners; and Article 84: Rights and obligations of communities who are allocated protection and production forest by the state is developed by the co-operatives in consultation with all members of the SGGs, approved by the district government and applies to all 40 SGGs and all the members of SGGs respect and comply. The leaders of the cooperatives/NACFO ensure that these are implemented in their entire forest, and approach the concerned government agencies to access the implementation of state policies. Applying the landscape approach, the co-operatives reduce forest patrol time and make better use of state policies. Moreover, all co-operatives become stronger with the active participation of all members of the 40 SGGs/NACFO in fighting with and preventing the illegal loggers from outside (not as single household/or some households like the way the government

still needs support to complete a full proposal ready to be submitted to the Thanh Hoa province ERP Management Board/FCPF Management Board 2 once ERP is implemented. This extension of the sub-project will also provide support to improve the capacity of NACFO in technical and project management skills to implement the same if the proposal is approved.



3. Project description

Objective: The sub-project's cost extension will help NACFO with its 1,206 household members to participate in ERP as a stakeholder.

Expected outcomes:

- Leaders of 4 co-operatives/NACFO improve their knowledge and skills on proper use of GPS and on accurate measurement of forest area, wood, carbon in the tree layers of natural forest and monitoring forest change (forest area, wood, Carbon) in their allocated and contracted forest areas, and development of the database;
- NACFO is capacitated to implement the "Community based initiative to reduce the emission by increasing the forest carbon stock"⁸ applying the approach of "Inter-community –

signs the forest protection contract before) and they have the collective voice (each can contribute their own knowledge to the issue) to work with the relevant government agencies such as Forest Rangers, Commune and District People's Committees on the issues relating to the forest. For example, participation in the State Forest Development Program through forest protection contracts or the much preferred forest use rights allocation.

Support for capacity building will be requested for the further strengthening of the alliance and its member cooperatives/SGGs for them to participate fully and effectively in ERP implementation. Other activities will include gathering required data like wood volume and forest carbon stock and establishing a database based on national standards; preparation and implementation of a forest protection plan including participatory carbon monitoring and overall forest changes aligned with state policies and programs and respecting customary laws and practices; skills trainings on forest carbon calculation (emissions and removals); development of a benefit sharing plan for the cooperative members consistent with the consent of the all members; and discussions on issues related to results-based payment and the environment and social safeguards among others.
